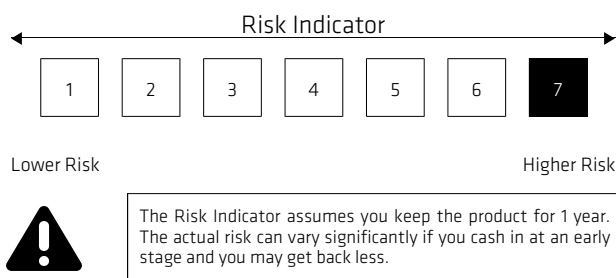
You are about to purchase a product that is not simple and may be difficult to understand.

What is this product?

Type	The product is a structured investment in the form of a tracker certificate under Swedish law and traded on the Nasdaq Stockholm AB as the primary marketplace.																						
Term	The product does not have a fixed maturity. You may exercise a right to sell the product to the Issuer at any time in accordance with (and subject to) the terms of the Prospectus. After exercise, you will receive a cash amount equal to the Settlement Amount (the original purchase price plus or minus any price movements in the underlying crypto currency less the relevant fee) less an early exit charge of 2.0%. The Issuer has the right to terminate the product at any time in accordance with (and subject to) the terms of the Prospectus. After termination, you will receive a cash amount equal to the Settlement Amount (the original purchase price plus or minus any price movements in the underlying crypto currency less the relevant fee).																						
Objectives	<p>The product is a special certificate, an exchange traded product, which is different from most investment products. The product's objective is to provide a daily return approximately equal to the performance of (the Digital Asset) Compass Crypto Reference Index Uniswap price across the 3 most liquid digital exchanges available to our methodology, before management fees and costs. This means that when the price of Compass Crypto Reference Index Uniswap rises by 1% on the 3 most liquid digital exchanges, the product should rise by approximately the same percentage. The methodology is created by CoinShares XBT Provider AB (Publ).</p> <p>To hedge its exposure under the certificates, the Issuer enters into an intra-group collateral management arrangement with the Guarantor, whereby the Issuer provides cash raised from the issuance of the Certificate to the Guarantor in exchange for a contractual promise to pay the settlement amount of the note (the original purchase price plus or minus any price movements in the underlying crypto currency less the relevant fee). To hedge its exposure under that contract, the Guarantor purchases the relevant crypto currency on a 1:1 basis, in both physical form and using derivative contracts. The product does not distribute dividends. What are the risks and what could I get in return?
